2016 DECLARATION OF NATIONAL LEAD POISONING PREVENTION DELEGATES

We are hundreds of delegates to the National Safe and Healthy Housing Coalition, the Lead and Environmental Hazards Association, and the National Association of Lead and Healthy Homes Grantees representing thousands from all walks of life. We are doctors, nurses, advocates, scientists, parents, business executives, local and state government officials, environmental professionals, inspectors, risk assessors, abatement contractors and citizens.

On this 4th day of May 2016 when President Obama is visiting Flint, we declare:

1. Urgent action and a comprehensive response are required now. Lead poisoning is entirely preventable; we know how to solve this problem.
2. Flint and other jurisdictions are only the tip of the iceberg, with over half a million children needlessly harmed by lead.
3. Tens of millions of U.S. homes have lead water pipes, lead-based paint, and lead-contaminated dust and soil.
4. The United States failed to meet the 2010 goal to eliminate childhood lead poisoning set by the President's Task Force on Children's Environmental Health Risks and Safety Risks in 2000 because funding was not adequate.
5. For every \$1 dollar invested in HUD lead hazard control, the nation gains \$17- \$221 in savings.
6. Enforcement is currently inadequate and must be increased at all levels of government.

THEREFORE, the nation's budget must not be balanced on the backs of our children. Congress must immediately restore and expand funding for CDC's Healthy Homes and Lead Poisoning Prevention Program to at least \$35 million to provide surveillance of children's blood lead levels in all fifty states and territories, and HUD's Office of Lead Hazard Control to at least \$230 million. This is a tiny fraction of the national government budget and well worth the investment.

THEREFORE, Congress and the Administration must embark on a muscular, sustained effort involving 3 inseparable parts--finding lead hazards, fixing them so children are not harmed, and full funding.

THEREFORE, Congress and the Administration must provide emergency funding to Flint and other areas with similar findings.

THEREFORE, Congress must fund and the Administration must develop and implement a new national plan including all government agencies to replace lead drinking water pipes and eliminate lead hazards in housing, schools and other places children frequent.

THEREFORE, Congress must fund and HUD must require lead-based paint risk assessments to ensure that federally assisted housing is safe from lead exposures for children.

THEREFORE, the Administration must update all outdated lead regulations using the most recent science.ⁱ

THEREFORE, all at-risk children should have their blood tested at least twice before age two, especially Medicaid-eligible children.

THEREFORE, Congress must provide grants, tax credits, and incentives to address lead hazards in low-income privately owned homes with children where the need is greatest.

THEREFORE, disclosure must be enforced and meaningful and Congress must act to make results of lead water pipe and lead paint hazard assessments available to buyers and renters to incentivize remediation before children reside there.

THEREFORE, Congress and the Administration must act to stop U.S. paint companies such as Sherwin-Williams from making, selling, or applying new lead paint and work to ban it worldwide.

THEREFORE, Congress must fully fund Head Start, special education and other needed programs and interventions for children with elevated blood lead levels.

THEREFORE, Congress must fund new research to find better ways to identify and remediate all lead hazards and all people at risk, especially children, and conduct research on how best to help children already poisoned. Research on lead is at its lowest funding level in 20 years.

WE CALL ON CONGRESS AND THE PRESIDENT TO INVEST IN OUR CHILDREN AND OUR FUTURE BY:

1) FINDING THE LEAD PROBLEM;

2) FIXING IT USING BOTH SHORT AND LONG TERM PROVEN METHODS; AND

3) FUNDING IT.

WE MUST HAVE ALL THREE.

WE OPPOSE A PIECEMEAL, REACTIVE STRATEGY THAT RESPONDS ONLY **AFTER** CHILDREN HAVE BEEN HARMED.

WE SUPPORT PROVEN STRATEGIES THAT PROTECT CHILDREN **BEFORE** THEY ARE HARMED.

ⁱ Regulations needing updating based on the latest science include but are not limited to:

- EPA Safe Drinking Water Regulations – last updated 25 years ago.
- EPA Lead Dust and Soil Regulations – last updated 15 years ago.
- OSHA Lead Standards – last updated in 1978 (industry) and (1996) construction.
- HUD – Federally Assisted and Owned Housing – last updated 16 years ago.
- HUD/EPA Disclosure – Update the 1992 Housing and Community Development Act to make disclosure meaningful. When we buy or rent an older home, require a test to show where the lead paint and lead water pipes are, not just check a box saying “I don’t know.”
- EPA Renovation, Repair, and Painting – issued eight years ago. Require dust testing at the end of the job to ensure that it was cleaned up correctly and no hazards remain as is already the case in HUD housing. Make training and enforcement more widespread.
- EPA Public and Commercial Building rule.
- State and local regulations and policies.
